REGULATIONS GOVERNING FELLOWS AND FELLOWSHIPS.

1. There are four fellowships in the University of Tennessee, each worth \$200.00 per annum, which may be held by any graduate of a college of recognized standing, or anyone whose education is equivalent to that represented by a college degree. Those about to take such a degree are eligible as candidates.

2. Fellowships are only granted upon application. Applications must be accompanied by evidences of scholarship, original ability, and general worthiness, such as theses, published writings, testimonials from instructors, outline of educational course pursued, distinctions gained, degrees taken, and the like. Such applications must be in the hands of the President of the University on or before May 1st of the college year preceding that during which the fellowship is held. Applications should contain a definite statement of the special studies which the applicant desires to pursue.

3. All fellowships shall be filled each year. Fellows may be reappointed for one additional year only. Applications for reappointment should contain a full account of the work of the preceding year and be accompanied by theses, results of examinations, and other evidence showing that solid results have been obtained. Preference will be given, in making appointments, to students pursuing regular courses leading to post-graduate degrees and pledging themselves to complete such a course, if the fellowship is continued.

4. Appointments will be made, and work for the succeeding year will be assigned, as far as possible, before Commencement of each year.

5. Each fellow shall pursue his studies under the direction of the professor or professors in charge of these departments, and these professors shall report semiannually to the President regarding the progress of such students.

6. Some University work will be assigned the fellows by the President, to be limited to one hour of teaching daily, or laboratory, shop, library, or some other practical work two hours daily.

7. Fellows may be removed by the President at any time, for gross abuse of their privileges, neglect of their work, or any conduct injurious to their or the University's interests.

8. Vacancies in fellowships, due to resignation or other causes, shall be filled as they occur.
