1990 Census Update

The 1990 census population figures for Tennessee cities have been finalized by the U.S. Census Bureau. The information is now available to the general public. Attached is a chart showing some population data for each of the 339 Tennessee cities.

In the first column is an alphabetical listing of all Tennessee incorporated municipalities. The second column shows the population of each city as certified in July 1990 by the Tennessee Local Planning Office. This figure is used to determine distribution of 1990-91 state shared taxes, (July 1, 1990). The third column lists the 1990 federal census population.

The fourth column presents the projected revenue that each city would collect in the 1990-91 fiscal year from state shared taxes, based on the planning office's population figure. The fifth column calculates the local share of state shared taxes if the 1990 federal census figures were used instead.

The final column shows the projected impact, in dollars, on each city if its 1990 federal census population were used for distribution of state shared taxes in place of the planning office figure.

These numbers reflect the difference in revenue a city would collect from state shared taxes using July 1, 1990 state certified population figures and comparing that number with the 1990 federal census figures. For the purpose of this comparison, it is assumed that the dollars available for distribution to cities is constant (\$205,776,761). The only variation is the city's population as a percentage of the total state population. The 1990-91 per capita distribution rate was projected to be \$73.83, while the 1990 federal census amount would be \$76.11.
