

MEMORANDUM

SUBJECT: Election of Vice President and Provost of the University

Shortly after Provost John Peters announced that he would assume the presidency of Northern Illinois University, I asked Dr. John Prados, former Vice President for Academic Affairs and currently University Professor in chemical engineering, to chair an advisory committee to conduct a search for Provost and Vice President in accordance with the Board-approved plan for filling Senior Administrative Officer positions. We contracted with AT Kearney, a nationally known search firm, to assist us in identifying potential candidates for the position.

A position announcement was distributed to more than 700 institutions of higher education, and an advertisement was posted in *Black Issues in Higher Education*, and the *Chronicle of Higher Education*.

A total of 46 individuals applied for the position or were identified by the search firm as viable candidates. After thorough review of all applicants, the committee selected eight candidates for campus visits. Two of the candidates withdrew from consideration, and the other six were on campus between January 30th and February 9th. Those who visited campus were Loren Crabtree, Provost at Colorado State University; Jack Burns, Vice Provost for Research at the University of Missouri – Columbia; George Wright, Senior Vice President for Academic Affairs and Provost, The University of Texas Arlington; Karen Sowers, Dean of Social Work at The University of Tennessee; Dick Edwards, Interim Provost at the University of North Carolina Chapel Hill; and Dick Gourley, Dean of Pharmacy at the UT Health Science Center. Each candidate spent a day and a half on campus and met with the president's cabinet, the university community, the provost staff, the search committee and myself. Every group had an opportunity to submit a written evaluation of each candidate.

After the campus visits, the search committee met to assess the strengths and weaknesses of the candidates. I met with the committee on February 15th and they submitted to me a list of three candidates they deemed acceptable. I invited Dr. Crabtree and his wife to the meeting of the Board of Trustees in Memphis on February 22nd. At that time, many of you had a chance to meet and talk with Dr. Crabtree.

Dr. and Mrs. Crabtree visited the Knoxville campus again on February 23rd. After careful consideration, I concluded that Loren Crabtree was the most qualified person for the position of Vice President and Provost. His experience at Colorado State parallels our aspirations for The University of Tennessee, he is highly regarded by his colleagues at Colorado State and other universities, and all who met him believe he will be a great addition to the University. He is excited about UT's goal to move into the ranks of the Top 25 public research universities, and he believes the research centers of excellence are "right on the mark" as to what we need to do to achieve our goal.

I am attaching a copy of Dr. Crabtree's curriculum vitae for your review. You will note that he is not only an able administrator but a highly respected scholar in the field of Asian history.

Therefore, I recommend election of Loren Crabtree as Vice President and Provost of the University, effective July 1, 2001, with an annual base salary of \$200,000. He will receive other benefits consistent with his position as Vice President and Provost and an Officer of the University.

The initial term of his appointment as Vice President and Provost will be three years, beginning July 1, 2001, and ending June 30, 2004. Thereafter, his appointment will be on a year-to-year basis.

If he is elected by the Board, I recommend the university initiate the process required by our tenure policy to authorize his appointment to the History faculty with tenure, including review by the departmental faculty.

Johnnie Amonette has called a meeting by conference call of the Executive Committee for 9:30 a.m. (eastern time) on Thursday, March 8th to act on this recommendation. Any other member of the Board is more than welcome to join us in the call. Simply contact Linda Logan at 974-3245.

Recommended Action: Election of Loren Crabtree as Vice President and Provost, effective July 1, 2001, with the compensation and terms described above.

The Provost is the chief academic officer of the University, a Carnegie Class I, land-grant university enrolling 20,000 undergraduate and 3,000 graduate students. The Provost is responsible for all academic matters and is a member of the Executive Budget Committee, the President's Cabinet, and the Faculty Council Executive Committee. The ten academic Deans report directly to the Provost, as do the Directors of numerous programs, including the University Honors Program, the Office of Instructional Services, the Center for Teaching and

Learning, the Help/Success Center, the Division of Continuing and Distance Education, and others. The Provost is responsible for approximately 75 percent of the University budget.

DEAN, College of Liberal Arts, Colorado State University, 1991-1997.

The Dean is the chief administrative officer of the College, the largest at Colorado State University. The College enrolls approximately 3,600 undergraduate and 500 graduate students in 12 academic departments and several interdisciplinary teaching and research centers, and delivers about 30 percent of all instruction in the University. It offers a variety of Bachelor's degrees; the Master of Arts, Master of Science, and Master of Fine Arts; and the Ph.D. The College has an annual budget of approximately \$19 million and employs 290 FTE faculty. The Dean has final responsibility for the College's curricula and instruction, budget, personnel, research and development, compliance with equal opportunity and affirmative action regulations, and other administrative matters. The Dean's Office staff includes two Associate Deans, a fiscal officer, an office manager, a professional adviser, a career counselor, a Director of Development, two network managers, and four additional support staff.

ASSOCIATE DEAN, College of Arts, Humanities and Social Sciences, Colorado State University, 1987-1991

As Associate Dean, I was responsible for curricular review and implementation, the College's \$800,000 temporary instruction budget, personnel evaluation, funded research and development, affirmative action and equal opportunity, and other administrative duties assigned by the Dean.

ASSISTANT DEAN, College of Arts, Humanities and Social Sciences, Colorado State University, 1985-97.

As Assistant Dean I was responsible for instructional support, advising and student services, and liaison to Student Services. During my tenure, the College was home to all of the University's undeclared majors.

ADMINISTRATIVE DEAN, Semester at Sea, University of Pittsburgh, Fall Semester, 1986, Fall Semester, 1991

The Administrative Dean is the Chief Executive Officer of the Semester at Sea voyage around the world. In this position, I supervised a faculty of 25, an administrative staff of 50, and approximately 450 college students during the 100-day voyages. I managed all aspects of the ship's program, including shipboard instruction, in-port travel, finances, student life, communication with the United States, and liaison with the ship's captain and 200 crewmen.

SHARED GOVERNANCE

I have served on more than forty faculty committees over the past 20 years. These include the Faculty Council Steering Committee, the University Strategic Planning Committee, and the Faculty Council International Programs Committee. I am past-president of the Western Conference, Association for Asian Studies (1983-84).
