part, for and in consideration of the sum of One (\$1.00) dollar
to them in hand paid by the said party of the second part, the
receipt of which is hereby acknowledged, and under authority
given by the Legislature of Tennessee by Act passed April 1st,
1919, (Chap. 92 of Public Acts of the General Assembly, 1919),
have granted, bargained, sold and conveyed, and do hereby grant,
bargain, sell and convey unto the said party of the second
part, the following described premises, to-wit:

Situated in District No. One of Knox County
Tennessee, and lying within the Second Ward of the City
of Knoxville, at the South East corner of Main Avenue
and High Street (now Broadway), and thus bounded:

BEGINNING at the intersection of the South line
of Main Avenue with the East line of Broadway (formerly
High Street;) and running thence Southerly with the East
line of Broadway one hundred and sixty-three (163) feet,
more or less, to the North side of an alley called
Spring Street in the deed from Strong hereinafter mentioned;

Female Institute Trustees, held at the
Office of Judge Hugh L. McWhorter at 4 o'clock
P.M. this day, there were present, Messrs. C. S.
Newman, R. P. Bellows, L. A. Tyson, Rush Beason
James Corran, A. P. White & Lewis Tillman.

The President (Judge McWhorter) being unable
by reason of sickness, to be present Mr. C. S.
Newman was called to the Chair, and he
stated the object of the meeting.

Minutes of previous meetings were
called for, but none were present.

The Treasurer, Dr. A. P. White, made brief
report of monies received and disbursed, &
it appeared that he had now in hand \$162.³²
with some bills outstanding against the Board.

The Secretary was instructed to ask from Prof.
C. C. Ross, who has for some years past occupied the
building, a statement of his account with the Board
as he has kept it.

There was a general discussion of, or ex-
change of views upon, the question of the ^{duty}

Board of Trustees to make some use of the School Property, which would carry out the purpose of the Original Donors. The Conditions of the Deed or Deeds made early in the last Century were considered; and all the Board expressed desire to see a good School for Girls Continued. It was announced by Mr. Gettys that Prof. Ross had given up the work and that some one would have to be found to succeed him. All thought a good female School should be established in and supported by Knoxville. Upon motion of Col. Lyman only seconded, it was unanimously resolved that an effort be made without delay to secure some Educator, man or woman, to take the property and open in the Fall and build up a girls School; and to that end it was moved and carried that the Chair appoint a Committee consisting of Judge McChung, and Messrs Gettys and Hazen; and they were accordingly so named and charged, being also authorized to advertise in their search, in such manner as they might deem advisable.

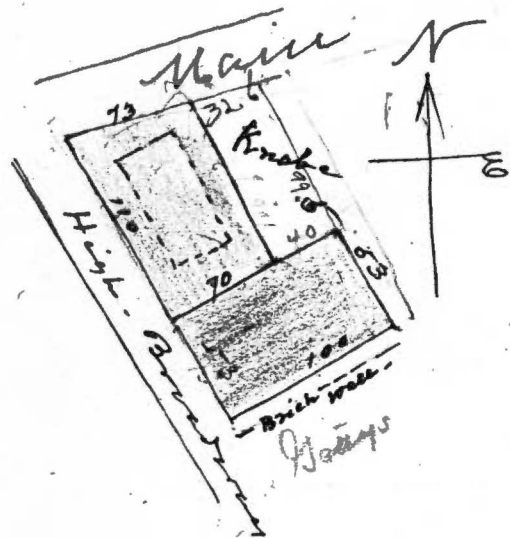

Meeting of Trustees

East Tennessee Female Institute

At a meeting the Trustees of the ~~East Tennessee Female Institute~~
^{on this 12th Sept. 1919} held at the office of Harris Tillman on Market Street, Knoxville, there were present the following, to wit:

Hugh E. McChesney, Ralph S. Hazen, R. P. Scotty, R. P. Whit, E. J. Stanford & Harris Tillman.

Judge Hugh E. McChesney, President of the Board, presided, and stated that the object of the meeting was to take final action touching the disposition of the property, real and personal, of the Institute. He stated further that in pursuance of a resolution of the Board of Trustees at its last meeting a bill was prepared and presented through the representatives of Knox County to the last Session of the Legislature, and passed into a Act and is now found as Chapter

92 in the Public Acts of 1919, authorizing the Trustees to convey the Real Estate of said Institute to the University of Tennessee; and that a deed in due form had been prepared and was now in hand and ready for execution.

Upon consideration of said Act & Deed, and it appearing that the

same were in accordance with the previous action of this Board, and in all respects in proper form, it was moved by Judge E. J. Sanford that due execution of said deed be at once made, which motion was seconded by Rush S. Hays, and vote being taken was unanimously carried: and execution of the said deed accordingly had as will appear the same being in language and form as follows:

Thereupon Judge Tribble called upon Dr. A. P. White, Treasurer, for a report of such fund as he might have in hand belonging to the said Institute: and the Treasurer immediately announced that he had on hand the sum of \$30.45 of the monies of the Institute ^{that there were no collectible assets} which report the Board received and approved.

Dr. A. P. White, referring to the service rendered by the Secretary, Mr. Tillman, in the preparation of the Bill for the Legislature, and the deed of conveyance to the University of Tennessee, herein above mentioned moved that the said fund be him held as Treasurer, after deducting the costs of the acknowledgment of said deed by the Institute and

the Trustees, be turned over as compensation to said Secretary.

Mr. R. S. Hayes seconded this motion.

Thereupon, Judge McBlung stated that he was a member of the Board of Trustees of the University of Tennessee, and thought that the compensation to the Secretary for the services rendered should be not less than fifty dollars; and that if the Trustees of the Institute should approve Dr. White's motion, he (McBlung) would endeavor to have the University supplement the allowance to the Secretary by such sum as would make his compensation reach fifty dollars. The suggestion of Judge McBlung was unanimously concurred in, and vote being taken Dr. White's motion was carried unanimously.

Thereupon the Trustees directed the President, Judge McBlung, to present to the University, or its President, Dr. Morgan, the correspondence of the Institute properly herein recited as executed, at such time and place as might be convenient.

Upon motion of Mr. Gettys, with one second from Judge Sanford, adjournment since due was taken.

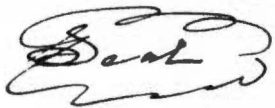
