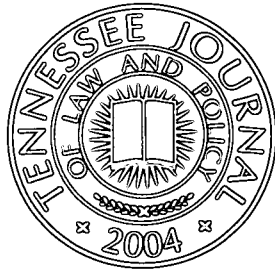

The JOURNAL could not have been established without the support of Thomas C. Galligan, Jr., the College of Law Dean and Elvin E. Overton Distinguished Professor of Law. His generosity and continued commitment to the TENNESSEE JOURNAL OF LAW & POLICY will ensure its continued success. Also deserving of our thanks is George W. Kunev, Associate Professor of Law and Director of the Clayton Center for Entrepreneurial Law, whose guidance in the early stages was, and continues to be, invaluable.
