ORDINANCE NO. 440.

---

AN ORDINANCE CLOSING A PART OF ROBINSON STREET, WORDEN STREET AND KINGS ALLEY IN MOFFETT'S ADDITION.

Sec. 1. BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF KNOXVILLE, That

Whereas, the public utility, necessity and convenience no longer requires that portion of Robinson Street lying between a projection of a line from Lot No. 108 across Robinson Street to Lot No. 111, being a projection of the Eastern line of said lots across Robinson Street; and from the point of said projection line, thence Eastwardly the full width of Robinson Street to the line of the University of Tennessee property, and said portion of Robinson Street is no longer needed for a public thoroughfare, and

Whereas, that portion of Worden Street within the corporate limits of the City of Knoxville from Robinson Street Southwardly the full width of Worden Street to a line caused by the projection of the Northern line of Lot No. 132 across Worden Street in a straight line to a stake in the Eastern line of Worden Street, and said portion of Worden Street is no longer needed or useful as a city street or thoroughfare, and

Whereas, Kings Alley, from Worden Street Eastwardly to the line of the University of Tennessee is no longer needed for a public alley or thoroughfare; as said portions of Robinson Street, Worden Street, and Kings Alley are shown upon a map thereof, which is hereto attached marked Exhibit "A" and made a part of this Ordinance.

NOW, THEREFORE, it is ordained by the Board of Commissioners of the City of Knoxville that said portions of Robinson Street, Worden Street and Kings Alley be and are hereby vacated, abandoned and closed as public streets, highways, avenues or alleys; but the City of Knoxville expressly reserves the right and easement to any and all drains and sewers lying in said streets and alley, or that may be necessarily constructed therein, in order to care for the surface water, and sewage, if any, running into the premises formerly occupied by said streets and this vacation is made subject to that right which is expressly retained, but without any interference with the use of the University of Tennessee.

Sec. 2. BE IT FURTHER ORDAINED, that this Ordinance take effect immediately upon its passage, the immediate preservation of the public health and safety requiring it.
