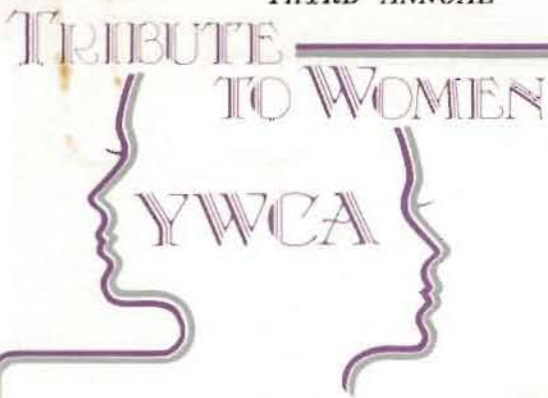

Coordinator of Non-Credit Programs

Full-time position available August, 1987 as Coordinator of Non-Credit Programs within the Division of Continuing Education.

QUALIFICATIONS: Baccalaureate degree required, advanced degree preferred; experience in continuing higher education non-credit course/seminar development and management. Individual should be self-directed with writing, marketing, and organizational abilities. Individual should have strong administrative skills and flexibility to follow-through with existing non-credit programs/courses as well as generate and manage new ones. Very desirable qualifications include demonstrated abilities to interact with people in a variety of settings ; successfully coordinate and manage simultaneous multiple activities; and prepare and execute individual course and program-wide budgets.

RESPONSIBILITIES: Position requires the skills and abilities necessary to identify the emerging educational, vocational, avocational, and training needs of individuals, groups, agencies, businesses, and industries; and to move forward to conceptualize and develop non-credit courses or seminars to help meet those needs. Position will require an individual who can work well with both academic-based continuing education client groups and those outside the educational setting. The coordinator must have the ability to develop, structure, budget, manage, implement, and facilitate a quarterly schedule of non-credit adult continuing education programs in a variety of delivery modes. Courses/seminars may be conducted on-campus or at selected sites in the Knoxville area; or, as appropriate, at sites across the state. Statewide travel is necessary. Collateral responsibilities include: attendance at staff meetings and assigned university functions, program promotion, participation in continuing higher education professional activities, and other reasonable administrative duties as assigned by the Director.

SALARY: Commensurate with qualifications. minimum of \$16,000.
