1. Welcome by Faculty Senate President

2. Minutes of the Preceding Meeting

3. Committee Reports

Academic Policy Committee

Stefanie Ohnesorg, Chair of the Academic Policy Committee, shared some of the topics to be discussed by the committee this year:

Appeals Committee

Credentials Committee

Curriculum Committee

Sibyl Marshall, Chair of the Curriculum Committee, shared some of the topics to be discussed by the committee this year, including basic standards for programs to add information specific to their programs.

Graduate Deans' Group

Joy DeSensi, Chair of the Graduate Deans' Group, shared the purpose of the committee and some examples of topics discussed by the committee.

- The Graduate Deans' Group meets five times a year to provide issues, advice, and counsel to the Graduate Council from an administrative perspective.
- The Graduate Deans' Group is the liaison between the Graduate Council and the Colleges and their departments.
- Examples of topics discussed include diversity recruitment efforts in colleges, evaluation of graduate teaching associates and assistants, changes in the GRE, approved Directors of Graduate Studies Responsibilities, approved Department/Program Graduate Student Handbook Template, and Office of Graduate Training and Mentorship.
- Hard copies of the 2011 – 2012 Department/Program Graduate Student Handbooks are due in the Graduate School Office today.

5. Brief Meetings of Committees

Chairs of the Academic Policy Committee, Credentials Committee, Curriculum Committee, Appeals Committee, and Graduate Deans' Group met briefly with their members.
