The Graduate Council meeting was called to order by Matthew Murray, Chair, on Thursday, October 4, 2007, at 3:00 p.m. in the 8th Floor Board Room, Andy Holt Tower.

1. Minutes of the Preceding Meeting

The minutes of the August 30, 2007 meeting were approved by the Council.

2. Committee ReportsAcademic Policy Committee

Ben Bates, Chair of the Academic Policy Committee, presented the report for the September 20, 2007 meeting.

- The College of Law proposed that the grade point averages for law students be changed from the current policy of rounding to the nearest hundredth to the nearest tenth so that it parallels other institutions. The College of Law has been asked to put their request in the form of a proposal. (Attachment 1)
- Undergraduate Council approved the use of plus and minus in grading. The committee requested input from graduate deans, department heads, and graduate directors before making a decision. (Attachment 1)
- The International English Language Testing System (IELTS) is being reviewed to determine if it will be accepted by the Graduate School as an additional language exam or supplemental to the current Test of English as a Foreign Language (TOEFL) required for international applications. Additional information is needed before a decision can be made. (Attachment 1)

Credentials Committee

Michael Zemel, Chair of the Credentials Committee, presented the report for the September 6, 2007 meeting.

- Council approved the committee recommendations on faculty approved to direct dissertations as presented (Attachment 2).

- The Credentials Committee also recommended to Council the request for change in the Bylaws pertaining to granting approval to direct for tenured associate professors who haven't been promoted to full professor within the ten years. Council approved the committee recommendations as presented (Attachment 2).

Curriculum Committee

David Dupper, Chair of the Curriculum Committee, presented the report from the September 20, 2007 meeting.

All changes were approved by the Graduate Council. (Attachment 3)

3. New Business

No new business.

4. Administrative Reports and Announcements

Carolyn Hodges, Vice Provost and Dean of the Graduate School, presented the following information:

- Statistics showing the 14-Day Graduate Student Enrollment and Graduate Fellowships were shared at the Graduate Directors' Workshop and the Dean, Associate Dean, and Department Head Retreat. The University's statistics are parallel to other US Institutions with the exception of reversal of the percentage of Asian and African American students. Graduate fellowships total approximately \$700,000 dollars. These recruitment fellowships are for one year with department support for the following years. Two fellowships are unfunded by the University. The Southern Regional Education Board granted fellowships to two UTK students for three years. (Attachment 4)
- The Graduate Fellowship Luncheon was held on October 3, 2007 to give the opportunity for the recipients to be introduced to the administrators and college deans.
- Edwin Cortez, Chair of the Graduate School Structure Task Force, has met with the committee. The task force has been divided into committees to begin work. They are expected to submit recommendations by the end of the semester.
- Cynthia Peterson, Chair of the Assistantship Task Force, will soon meet with her committee. This task force charge will take longer to complete. They are expected to submit recommendations by the end of Spring 2008 semester.
- Graduate Directors' Workshop was held on September 27, 2007. Numerous subjects were covered.
- The newly revised Best Practices in Teaching Workshop for this semester is going well. The workshop will be offered again next semester.

- Two employees with the title of Administrative Specialist I have been hired to work as graduation specialists for the Graduate School.
- The Professional Development Award Committee will meet next week to select the first recipients for this year. These awards are now given four times a year instead of six and restricted to tenured or tenure-track faculty.
- The Graduate Hooding Ceremony will be on December 14 at 4:30 p.m. in the Thompson-Boling Arena.
- Provost Holub is exploring the idea of a Teaching/Learning Center.

Graduate Deans Group

Mary Albrecht, Chair of the Graduate Deans Group, presented the report from the September 20, 2007 meeting. (Attachment 5)

University publishing and digital access to scholarship were discussed. A conflict may develop if the students put their publications on the web before the thesis or dissertation is complete. (Attachment 5)

Dr. Brad Fenwick, Vice Chancellor of Research, has been invited to the next meeting. (Attachment 5)

The group serves in an advisory capacity to the Dean and Graduate Council to assist in improving the Graduate School. (Attachment 5)

Graduate Student Senate (GSS)

Nicholas Cook, President of the Graduate Student Senate presented the report.

- The Graduate Student Travel Fund has awarded the first awards of this year. Awards are granted three times during the year. The GSS received 167 applications and made 46 awards in the amounts of \$100 to \$375. They are working to revise and further improve the application and evaluation process.
- The Love Your Libraries 5K and Fun Walk is being planned and ways to encourage participation are being discussed.
- An inquiry was made to see about whether departments furnish graduate handbooks to all graduate students. Guidelines had been issued to the departments last year, and the Graduate School received them. Cook requested that Hodges contact department heads and graduate directors requesting to see that each graduate student receives a copy of the graduate handbook in his/her department.

Graduate Council Chair

Matthew Murray, Chair of the Graduate Council gave the following report.

- A Bylaws Committee has been established with Stefanie Ohnesorg as chair.
- Five appeals have been received, which is more than were received in the last five years. These appeals can be avoided by carefully following the rules and procedures.
- Graduate Fellowship Luncheon was very impressive with the number of fellows and administrators in attendance.

5. Items from the floor

Linda Phillips discussed the dissertation workshop, which is being co-sponsored by the Graduate School and the University Libraries, to be held in January 2008. (Attachment 6)

A welcome was extended to Gregory Reed, Associate Vice Chancellor for Research.

With no further business, the meeting was adjourned at 4:00 p.m.

The meeting was called to order at 2:00 p.m. by Ben Bates, Chair. Bates reviewed the bylaws of the group.

1. Proposal from College of Law on Reporting of Cumulative GPA for Law Students.

The College of Law proposed that grade point averages (GPAs) for law students change to be rounded to the nearest tenth point. Monique Anderson, University Registrar, talked with the committee about how all GPAs are currently rounded to the highest hundredths of a point. Anderson also stated that the computing programmers had been consulted about the possible change for law students. The current grading policy for law students does not parallel that of graduate or undergraduate level students in other ways. Law courses have a numerical grading system rather than letter grades. Following a discussion of the proposal, the committee asked that the College of Law prepare a specific proposal for changes to the Graduate Catalog text on page 22 under "Law Courses" and on page 154 under "Doctor of Jurisprudence."

2. Plus/Minus Grading Proposal.

The committee discussed the grading scale that had been approved by the Undergraduate Council on Tuesday, September 18, 2007. The grading scale incorporates minus grades (B-, C-, D-) in the grading scale for undergraduate courses, plus a D+ grade as well. The committee discussed the rationale that was presented by the Provost's Office for the change in undergraduate grades. The committee asked that feedback be solicited from Graduate Deans, Department Heads, and Graduate Program Directors concerning whether a similar grading scale should be considered for graduate courses.

3. Proposal on IELTS.

A brief introduction on the International English Language Testing System (IELTS) was made and copies of the IELTS Handbook were distributed. The committee will continue the discussion of a proposal to include the IELTS score as an acceptable measure of ability using the English language for graduate admission on applicants whose native language is not English.

The meeting adjourned at 3:00 p.m.

Graduate Council approved the following change to the Bylaws and Operating Procedures for the Credentials Committee:

Delete section:

~~2) When a faculty member is awarded tenure and promotion to the rank of associate professor, approval to direct dissertations will automatically be granted for a period of 10 years or until promotion to professor, whichever comes first. If, after 10 years, a faculty member is not promoted to professor, approval to direct dissertations will not be extended except on a case by case basis (see #6) below.~~

Amend with **additions**:

3) When a **tenure-track** faculty member is **appointed or** promoted to the rank of **associate or full** professor, approval to direct dissertations will automatically be granted for 10 years and will be reviewed every 10 years thereafter, for so long as approval is sought.

Sections 3 through 7 should then be renumbered to 2 through 6.

949 Judicial Externship (4) Supervised fieldwork in selected state and federal trial and appellate courts. Students identify legal issues in pending cases, conduct legal research, prepare legal memoranda, and perform other judicial clerk duties under the direction of the assigned judge. Course is designed to refine the student's research and writing skills; to enhance the student's appreciation of the application of bodies of law already learned; to familiarize the student with court procedures, judicial decision-making, and the deliberative process; and to permit the student to observe and evaluate the style and demeanor of judges and lawyers in order to contemplate the development of their own professional style. Students are required to maintain a daily work log and weekly activities journal and to attend and participate in orientation and classroom component.

Repeatability: May be repeated. Maximum 18 hours.

The meeting was called to order at 2:00 p.m. by Mary Albrecht, Chair. Albrecht reviewed the bylaws of the group. She noted that the bylaws call for the Associate Dean of the Graduate School to serve as Chair of the group. Since Mary Papke has become an Associate to the Chancellor full-time and a search will be conducted this semester to replace her as Associate Dean, a member of the group was asked to serve as Chair. 1. Carolyn R. Hodges, Dean of the Graduate School, reported on the following Graduate Council and Graduate School activities:
 - Meeting with Chairs of the Graduate Council Committees to review the roles of each committee in the process of policy development for graduate education at UTK.
 - Reviewing curriculum process to analyze ways to streamline the steps. Provost Holub has asked that this review be done.
 - Changing the Appeals Committee to have appointed members and a Chair rather than an ad hoc group.
 - Working with the Professional Development Committee to actively solicit a broader participation across campus in the proposal competition.
 - Developing bylaws for the Graduate Council. Matthew Murray, Chair of the Graduate Council, noted that each of the standing committees has a set of bylaws but that the Council needs much more definition and structure than what is currently in place.
 - Reviewing alternatives to the current English language test for admission.
 - Discussing the possibility of instituting plus/minus grading along with the Undergraduate Council.
 - Developing joint degree programs. Hodges reported that she and Masood Parang are putting together a committee to study joint degree programs.

- Launching two task forces. One task force will review the structure of the Graduate School and develop some recommendations that can be presented to the Graduate Council and to the central administration. The second task force will review the policies and administration of graduate assistantships to develop recommendations for Graduate Council and central administration.
 - Developing a Diversity Plan for the Graduate School with the assistance of the Graduate Deans' Group.
 - Continuing the production of the Best Practices in Teaching Program designed to assist graduate teaching assistants/associates, post doctoral fellows, and new faculty.
 - Creating a workshop for doctoral students beginning their dissertations. Linda Phillips announced that the University Libraries and the Graduate School are collaborating on the workshop to be offered on Tuesday, January 8, 2008. Phillips asked the group to help identify students who could be targeted for attendance of the workshop.
2. Albrecht asked the group for input on the agenda for the group's meetings during the year. Members suggested discussion of the following items:
- The Bologna Agreement and possible changes in admission policy related to that European development of standardized 3-year bachelor's degrees.
 - Academic honesty related to graduate education.
 - Non-degree admission status for international graduate students.
 - Review of an article entitled "University Publishing in the Electronic Age." (<http://deepblue.lib.umich.edu/index.jsp>) Phillips reported that UTK has a scholarly archive that serves as an institutional repository.
 - Plan to update the information that was developed for the National Research Council (NRC) Doctoral Degree Survey. William Dunne reported that the process involved a verification of data that is helpful in creating valid program information.

Albrecht asked the group to propose possible guests to invite to the meetings during the year. Brad Fenwick, the new Vice Chancellor for Research, was discussed. Hodges will extend an invitation to him to attend a meeting soon to speak with the group. Other possible future guests mentioned were the new Director for the Center for International Education, the new Director of Institutional Research, and Linda Painter, Special Assistant to the UT President on Banner Software Implementation.
