### **CTAS** Partners to **Create TNData Portal**

The UT County Technical Assistance Service (CTAS) has partnered with the UT Center for Business and Economic Research (CBER) and the UT Department of Geography to create the CTAS/CBER TNData Portal, an interactive mapping, charting and data download Web site of demographic and economic information about Tennessee.

The project is an extension of the American Recovery and Reinvestment Act (ARRA) project led by CTAS's Jon Walden to implement the efforts of Brett Howell of CTAS and David Connor of the Tennessee **County Commissioners Association** to centralize widely dispersed government data for fast access and easy analysis by county associations and elected officials.

CBER partnered with CTAS on the project because it was seeking better web-based visualization tools for the business and economic research data it collects and compiles for research use and economic analysis for the citizens of Tennessee. CBER introduced the site at its June workshop on U.S. Census Data and Projection, showing how recent data from the American Community Survey can be geographically selected and then mapped, charted and downloaded (continued on page 2)

in Excel format at the county or tract level. The UT Department of Geography joined the partnership because it supplies similar information on its Tennessee Electronic Atlas. Dr. Bruce Ralston of UT Geography and Mike Meyers of CTAS developed a rich internet application (RIA) interface for the data collected by CBER and UT Geography student workers. The Web site also will supply tax and revenue information developed by Lynne Holliday of CTAS. The combined efforts of the three groups will reduce the effort required to keep data current and relevant.

In addition to helping IPS serve its outreach mission, the Web site uses innovative presentation tools that are drawing attention in academic circles. Featured in a paper presented at the First International Workshop on Web-Based Geographic Information management, TNData Portal "allows users to draw inferences based on their ability to construct multiple data visualizations and interact with those visualizations in an intuitive manner. The application facilitates the discourse between the user and the data without the software getting in the way."

## MTAS Wastewater Expert Speaks at Water Environment Federation Webcast

Brett Ward, UT Municipal Technical Advisory Service (MTAS) wastewater specialist, recently was a speaker for a Water Environment Federation webcast.

The Water Environment Federation provides worldwide leadership in the wastewater and sewer industry. This summer, they are conducting a series of webinar training programs. The first webinar was entitled, Phosphorus Removal – Tips for Operators, Trainers and Design Engineers. The speakers, in addition to Ward, were:

Ward presented two examples of chemical phosphorus removal processes being used in Tennessee. The plants discussed are located in Fairview and Lawrenceburg.

This was the Water Environment Federation's largest attended webinar to date with more than 650 official sites logged onto the session. This webcast is being offered in affiliation with U.S. EPA's 104(g) Wastewater Operator Assistance Program.



## TREEDC Members Brief Deputy Governor, TDEC Commissioner

Recently, 12 Tennessee Renewable Energy and Economic Development Council (TREEDC) Advisory board members held an informational briefing with Deputy Governor Claude Ramsey and Tennessee Department of Environment and Conservation Commissioner Bob Martineau.

The purpose of the briefing was to advise the new state administration about the various city and county energy projects initiated by TREEDC, a statewide network of city and county mayors working to promote renewable energy in Tennessee. TREEDC President/Pikeville Mayor Greg Johnson also explained the critical role that the UT Institute for Public Service (IPS), the Municipal Technical Advisory Service (MTAS) and UT President Emeritus Dr. Joe Johnson played in creating the council.

TREEDC Co-founder Emanuel Bailey discussed the council's involvement with biosolids conversion possibilities into syngas. Gibson County Utilities Director Pat Riley discussed potential compressed natural gas opportunities for municipal and county fleets.

## **Solution Point FAQs**

With the launch of a new learning management system, here are some tips:

How do I register for a class?

Logon to Solution Point, and search for the course or click on Course Catalog. After you select the course, click on the Register link next to the offering you want to register for.

### How do I register for Web-based training?

Logon to Solution Point, and click on the Course Catalog. Look for a folder in the Course Folders section that indicates it contains online courses. Click on that folder to view the online courses. Select the course you want, and click Enroll at CBT/WBT at the bottom of the screen.

### How do I cancel my registration?

Logon to Solution Point under My Learning, and select Training. Click on the course you want to cancel. Click Cancel at the bottom of the screen.

### How do I view my enrollments?

Logon to Solution Point, and select Training from the My Learning menu. Your enrollments will be displayed.

### How do I view or print my transcript?

Logon to Solution Point, and select Transcript from the My Learning menu list. Click Print Internal Transcript Report at the bottom of the screen. A new browser window will open, and your transcript will be shown. Use the Print function from your browser to print a copy of the transcript.

### How do I print a certificate of completion?

Logon to Solution Point select Transcript from the My Learning menu list. Look on the right of a course you have completed for an icon resembling a printer. Click that icon to print a certificate of completion for that course. The certificate will open in a new browser window. Use the Print function to print the certificate.
