Dear Friends of the Library:

Each year hundreds of new supporters of our Library Development Program join Alumni and other friends of the project, chiefly because they know that the statement "A mark of a Great University is an excellent library" is a statement of truth. In the year just ended, a giant step was taken toward achieving the project's ultimate goal, with contributions reaching record proportions. Since the program was initiated, your active participation has been responsible for the addition of approximately 32,034 books to the shelves of the libraries at Knoxville, Memphis, Martin, and Nashville.

Following is a summary of gifts for the six years recorded in five reports:

\$151,737.34	and	32,034 books	(Total, five Reports)

As in the past, we must give a generous share of the credit for the year's success to Dr. John C. Hodges, Professor Emeritus of English, who continues to serve as Coordinator for Library Development. The energy, enthusiasm, and devotion which Dr. Hodges gave to the teaching of English was, fortunately, transferred to this assignment which he voluntarily accepted. Your generous response to his leadership is most gratifying.

Much has been done, but the task is not completed. With student enrollment increasing dramatically, with research programs developing in new areas, and with the graduate population growing more rapidly than other areas of University activity, the continued search for income above the regular sources is imperative if the library is to grow to fill student needs. We trust that you will continue to include the library as a beneficiary of your philanthropy--and that we may have the pleasure of listing you in our annual library reports.


