A quorum of the voting members took part in the evote, with 19 members casting a vote to approve all proposals and one member abstaining.

- The Committee had decided previously to allow courses that transfer to UTK as an equivalent to an approved UTK Engaged Inquiries (EI) course to satisfy that same EI requirement without needing to prove the pedagogical EI method at the previous institution. The Committee submitted

a proposal stating that a student who transfers in a course that is equivalent to a UTK non-EI course may petition that the course count as EI provided the student can document that the course was taught in an acceptable EI format. This proposal only applies to the EI requirement because EI is pedagogically-based rather than content-based. The proposal was approved.

- As clarification, the Implementation Committee noted that each course in Expanded Perspectives (AH, NS, QR, SS, GCI, GCUS, and AAH) that have multiple designations can count only once; however, if the course is repeatable, the course could count in one category the first time the student completes it and in a different category when the student repeats it. DARS will apply the credit(s) automatically.
- The Committee discussed the following items that did not require approval:
 - The common database for Committee members to view course proposals
 - Samples of proposals to post on the General Education website
 - Rubrics
 - Course proposal form for the EI category
 - WC Guidelines
 - Details of the assessment process of Vol Core courses during a ten-year cycle
 - Current policies regarding transfer courses applying to UTK general education requirements
 - Vol Core logo to be used on course syllabi
