MINUTES: JOINT MEETING OF THE COMMISSION FOR BLACKS (CFB) AND THE BLACK RECRUITMENT ADVISORY COMMITTEE (BRAC): DECEMBER 16, 1998

A joint meeting of the CFB and BRAC was held on December 16, 1998. The purpose of the meeting was to jointly discuss issues raised in the recently published BFSA "Position Paper" which called for an update on the progress of the 21 recommendations identified in the CFB Task Force Reports of 1990 and 1994. The BRAC and CFB chairpersons briefly discussed the purpose of their respective committees as well as activities underway. There was open review and discussion regarding the 21 recommendations.

The members stated that some of the recommendations had been met and required no additional work. These included the following recommendations: 1, 6, 9, 15 and 20. The remaining recommendations will require additional review and work. To do so, four basic sub-committees were established to address particular recommendations. Persons were assigned to work on various sub-committees. In addition, two recommendations (#21 and 22) will be addressed by the body as a whole.
