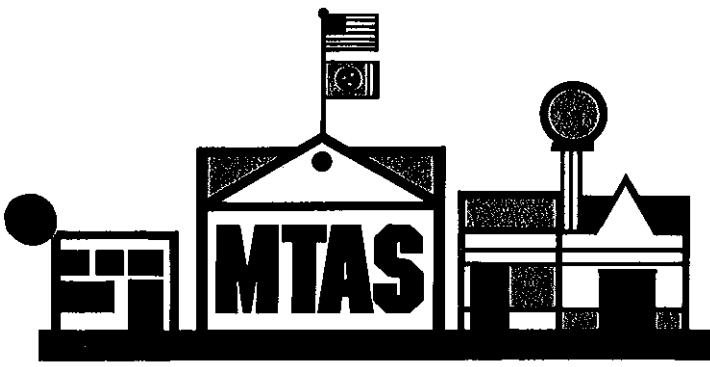

## REVENUE SHARING ACTUAL USE REPORT: PUBLIC NOTICE

Since this is the first year the Municipal Technical Advisory Service has served as a collection entity for data on local and intergovernmental revenues and data on the actual expenditures of Revenue Sharing Funds for Tennessee municipalities, many cities may forget to publish a notice that the report has been filed.

The publication requirement was noted on Page 5 of the TN-2 form received by Tennessee cities. This bulletin serves as a reminder of that requirement. If your city has not published the notice, do so immediately, regardless of whether the 10-day deadline (after filing the form) has been exceeded.

A sample notice that can be used:

### PUBLIC NOTICE

The report on the uses of general revenue sharing funds for fiscal year 1981-82 has been submitted as required by (name of government).
