GUIDE TO USE OF THIS DIRECTORY

After the name of each city is the county name, in parenthesis, in which the city is located. After the county name is a letter showing in which grand division of the state the city is located, East, Middle, or West. The figure shown after the capital letter is the 1950 population of the city. The last entry on this line is the month and year of the next city election.

For each city that furnished the requested information, on the second line is shown the dates, time, and place of the meetings of the governing body.

The entries after the names of the city officials in the columns headed "Term" indicate (1) for elected officials the month and year in which their term of office expires and (2) the letter "A" indicates that the official is appointed rather than elected by popular vote. These entries are omitted for some cities because they failed to furnish the requested information.
