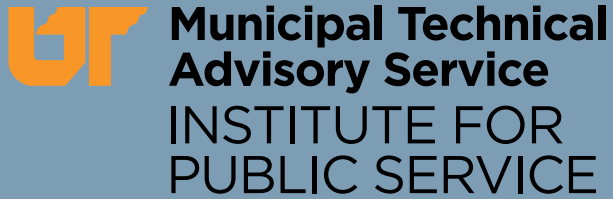

### How Is MTAS Doing? 2015 Biannual Customer Surveys

**JUST LIKE YOU**, we at MTAS want to know how we're doing...in our own eyes, but, more importantly, in yours. So we use some tools to measure that and many of you helped us recently by responding to a survey that was sent to MTAS customers by our parent organization, the UT Institute for Public Service.

About 500 of you replied with your thoughts, ideas and concerns. You answered five basic questions that have been standards in this biannual survey for many years. In your responses you told us we're doing pretty good across the board, and even improving in the two years since we last surveyed our customers. While that information is always good to see, and appreciated by all of us at MTAS, it's what you told us when we asked the question, "What do you see as problems facing your city government in the next 10 years?" that will inform us as we plan for the future. Several hundred of you took the time to speak your mind on that one. And what you said tells a strong story. The economy is better, but it's sure not great. Revenues are decreasing while expenses are increasing. Infrastructure is aging and needs greater attention than what available resources can provide. Knowledge and skill sets needed in municipal government are not plentiful enough in the applicant pool when working to fill staff vacancies. Unfunded mandates are a burden on dwindling budgets. And the list goes on.

MTAS staff is carefully considering what we heard you say in the survey, and we'll use that information to focus our efforts on what is important to you. We want to assist you in meeting those problems and issues head-on today while working to lessen the affect they may have on your city in the future.

# FMLA Forms Now Updated by DOL

**FOR THOSE OF YOU** who maintain hardcopies of FMLA sample forms, as provided by the Department of Labor - Wage and Hour Division, you will need to destroy outdated revisions, and replace with the newly issued (Effective June 1, 2015) forms.

The expired Family and Medical Leave Act (FMLA) forms (February 28, 2015) that the U.S. Department of Labor (DOL) said to keep using have now been replaced. These new FMLA forms don't expire until May 31, 2018.

Other than a change in the expiration date, it appears that the only substantive change to the forms is a reference to the Genetic Information Nondiscrimination Act (GINA) in the WH-380E, 380F, 385, and 385V medical certification forms. In the new FMLA forms, the instructions to the healthcare provider (Section II on the forms) states:

Do not provide information about genetic tests, as defined in 29 C.F.R. § 1635.3(f), genetic services, as defined in 29 C.F.R. § 1635.3(e), or the manifestation of disease or disorder in the employee's family members, 29 C.F.R. § 1635.3(b).

According to GINA regulations, if an employer provides a safe harbor notice with the request for medical certification, any receipt of genetic information in response to the request will be considered inadvertent (and will not violate GINA).

# Volunteer Fire Departments Now Required to File Annual Financial Reports

**STATE LAW NOW REQUIRES** every volunteer fire department receiving appropriations from the federal government, the state, a county, or a municipality to file an annual financial report with the Tennessee Comptroller of the Treasury and with each local government from which the volunteer fire department received an appropriation.

This new reporting requirement is effective for the year ending June 30, 2015, so volunteer fire departments meeting the criteria in the law are required to submit an Annual Financial Report of Cash Receipts, Disbursements, and Balances For the Year July 1, 2014 through June 30, 2015 report (form attached) to the comptroller by December 31, 2015.

Volunteer fire departments that receive all of their funds from a municipality or county through that city's or county's budget still need to file a report. On the form, indicate a cash available balance of zero for July 1, receipts should equal the amount of money actually expended on the fire department for the reporting period, disbursement should equal the amount of money actually expended on the fire department for the reporting year, and indicate a cash available balance of zero at the end of the year (June 30). If the fire department received any grants, money from fund raising activities, etc. those funds would need to be listed, too.
